

### Market access for agricultural and processed products

### A) EU concessions

**Full liberalisation:** 

80.4% of tariff lines

82.3% of trade value

**Sensitive products:** 

19.6% of tariff lines

17.7% of trade value



#### Market access for agricultural and processed products

### A) EU concessions

- Zero-duty TRQs for all the sensitive products.
- Volumes based on traditional trade flows.
- For many TRQs:
  - Initial volume at the entry into force of the agreement.
  - > Then, linear increase in five years.

Barley, flour and pellets	250.000-350.000 t*
Oats	4.000 t
Maize, flour and pellets	400.000-650.000 t*
Barley groats and meal; cereal grains otherwise worked	6.000-7.500 t*
Malt; wheat gluten	7.000 t
Starches	10.000 t
Bran, shaps and residues	15.000-20.000 t*

Sugars	20.000 t
Other sugars	10.000-20.000 t*
Sugar syrups	2.000 t
Garlic	500 t
Mushrooms	500 t
Mushrooms-additional (fresh)	500 t

#### Market access for agricultural and processed products

### B) Ukraine concessions

- Complete liberalisation of many products with strong EU offensive interest (e.g. cheeses, olive oil, wine...).
- In sensitive tariff lines (e.g. meat products, F&V, dairy...) the EU will benefit of 20-50% duty reductions.
- Ukraine will open three TRQs (pork, poultry an d sugar)
